### CLARENDON TOWN BOARD Meeting Highlights - April 2023

#### HIGHWAY/WATER DEPARTMENT REPORT -

Superintendent Tracy Chalker reported two salt runs this past month. The town has worked with the county removing trees that would be a potential danger; approximately 20 trees have been removed or trimmed. New Guinea Road and McAllister Drive have been graded; potholes have been temporarily filled. Black top plants plan to open April 24th; the town may be able to get blacktop on Thursday for filling potholes. Plows and wings have been painted in preparing trucks for summer work. The crew has done some ditching and culvert cleaning. Highway employees have attended a safety training at the county to include trenching, traffic safety, sexual harassment and confined spaces. There were three new water hook-ups and the first quarter water meter reads are complete. General water maintenance is being done. Superintendent reported that when there is no more danger of a freeze, he will use the automatic flusher on the hydrants. The crew has been cleaning up the cemeteries; Homer Mathes has been hired to mow the cemeteries for the season. It was reported that a lot of garbage and tires are being picked up roadside this year; worse than ever. Everyone has garbage pickup and each residence is allowed to dispose of five tires at the highway garage. Superintendent sees no reason for the dumping; Powerline Road and the top of the hill on Glidden Road seem to be the hotspots!

#### PLANNING BOARD REPORT -

Planning Chairman Dave Griggs informed that there are three solar farms going up in the Town of Sweden. Two have begun work; Wolf Solar Farm on the north side of Route 31A across from West Sweden Road: Mantisi Solar Farm at Sweden Walker and Fourth Section Road and the third one, approved but not started is Kreher Solar Farm by Byrne Dairy on Sweden Walker Road. All are under five megawatts. Chairman Griggs submitted the following written report: 03-28-2023 (Regular meeting) Pre-conference for the transfer of Non-Conforming use, 16179 East Lee Road from Kevin Manna to Rick Gallo. Applicant failed to appear at the meeting. A motion was made, second and approved to table this item for our next meeting. 04-11-2023 (Regular Meeting) Pre-conference for the Transfer of Non-Conforming Use, 16179 East Lee Road from Kevin Manna to Rick Gallo. No change in the status of the current operation (motor vehicle repair) will take place as a result of this transfer. Mr. Gallo has applied for his authorization to operate a repair shop with NY State. He has hooked up public water and has had his electrical service upgraded. A sign has been installed and is the proper size according to the zoning ordinance. Outdoor lighting was discussed, Mr. Gallo plans on putting one light over the door and one on the sign. They will not shine out on neighboring properties or the state highway. He will remove the existing shed to make room for parking cars. His hours of operation will be Monday- Saturday 7am to 7pm. Temporary storage up to 16 tires behind the building until they can be disposed of was approved. Used motor oil will be utilized in the waste oil furnace. All conditions specified on the existing certificate of non-conformance remain in place. No other issues were noted. Applicant requested waiver from Pre-Conference to formal. A motion was made, seconded and approved to move this application to a formal stage. A motion was made, seconded and approved to grant approval for transfer of Certificate of Non-conformance contingent on the following conditions; Mr. Gallo will provide proof of ownership and a copy of the assigned certification from the New York State Department of Motor Vehicles (DMV) to operate a motor vehicle repair facility to OIO Ierlan.

#### HISTORIAN / HISTORICAL SOCIETY REPORT -

Historian Melissa Ierlan submitted the following written report: John Janelli informed me of a book that was purchased by Carl Akeley as a 12-year-old boy called The Taxidermists Manual by SH Sylvester published in 1863. Carl purchased it for \$1 and this is what got him started on the lifelong passion of taxidermy. I have purchased and printed a digital copy for the historians' collections. The Orleans County Historical Association is running summer events and the Clarendon Historical Society will be hosting a cemetery talk on a Sunday in August at Hillside Cemetery. Dates to be announced. The Clarendon Historical Society received grant money to purchase floor lamps for the chapel. They have been ordered and should arrive in June. Grant money was also received on behalf of the Holley Murray Historical Society to purchase a historical marker to commemorate the 9 boys from Holley that died in Viet Nam. The sign has been ordered and will take about 6 months to be made.

I finished painting two more historical markers this winter for the Villages of Albion and Millville. They will be placed when the weather is warmer. I have been invited to give a talk on Lillian Bentham to students in the sixth grade. She is the Titanic survivor who is buried in Hillside Cemetery.

#### SUPERVISOR REPORT -

Deputy Supervisor Allen Robinson thanked the Fire Company for the invitation to its Annual Installation Banquet on Saturday, April 15th. Deputy Supervisor Robinson informed that the Town is renewing its Bond Anticipation Note for some of the waterlines and highway truck at \$2,129,600; net interest is 3.4824% which is an increase of 1.3924 from last year.

#### CORRESPONDENCE -

The Town received \$46,216.00 from the Orleans County Treasurer for first guarter 2023 sales tax revenue.

#### **OLD BUSINESS -**

The proposed zoning ordinance amendments regarding short term rental and above ground propane tanks have been sent to the County Planning Board for their review.

#### **NEW BUSINESS -**

Pursuant to adopted state legislation, the town clerk shall issue a one-day marriage officiant license upon request. The applicant must apply for such license in the same town office as the couple to be married purchased their marriage license. Cost for said license is \$25.00. The town board added this fee to the town fee schedule. The Town received two proposals for portable restroom service; Rochester Portable Toilets and Best Rentals. The board accepted the proposal from Best Rentals at \$80 per unit.




### Híllsíde Sketches

## George J. Sturges

was born in Clarendon, NY in 1830 To Zina and Nancy Sturges. George married Maria and they had 3

children. Edward born in 1858, Alva born in 1866 and Gertie born in 1870. He lived his entire life in Clarendon. The Sturges home was on lot 155 on Upper Holley Road.





George went off to the civil war in October of 1862. He was a member of the 151<sup>st</sup> regiment of NY State.

In 1871 he was a member of the Methodist Society in Clarendon and was appointed sexton in 1871. He also was a constable in Clarendon in 1877. Maria Sturges died in 1890 and was buried in Mt. Albion cemetery. After her death George moved in with his daughter Gertie and her husband until his death in 1914. George was buried in Hillside Cemetery in the original veterans section.



There are no floors in <u>Heaven's Café</u>, tables and chairs rest upon clear, blue skies, patron's stroll among cotton-like clouds and watch their former worlds go by. And as they sip their coffees and teas, and reflect upon the years gone by, the simplest word, so often overheard, is . . . why!

"Why did I do this or that?" and "why was it so important back then?"

"Why was I blind to the consequences of the choices I made?" "Did the means truly justify the ends?"

I remember the first time I entered <u>Heaven's Café</u>, I was amazed, for all of it was exciting and new to me! In the back at a table playing cards, sat union General George S. Mead and confederate hero, General Robert E. Lee! Their conversation was congenial at first, but then grew heated as they dealt and played the game.

And I thought: "Are they debating the folly of a war in which thousands were killed or maimed?"

The generals quarreled, their voices grew louder, and then suddenly, they pushed back their chairs, and each man sprang to his feet!! The café grew silent as the generals reached for their sabers, and then solemnly . . . they looked toward earth in defeat.

And far below, we all watched in horror as two great armies converged, canons rolled like thunder, as men fell asunder at a place called . . . Gettysburg!!

The soil turned crimson with the blood of the fallen, and horses shrieked in terror, Death rode high in the saddle across the great meadow, a pale horse his faithful bearer!

Brother against brother, father against son, their rivalries tainted by the colors of blue and grey, I pondered, "Where are they now, those poor misguided souls?' Do they languish here in Heaven's Café?"

And I thought: "Who bares the burden for the lives swept away, on the world's three most infamous days?" And as I looked to the generals I found my answer, here . . . in <u>Heaven's Café</u>.

Lee fell to his knees, and Meade followed suit as they re-lived the Holocaust below, their tears fell like rain as their souls bore the pain, of the Gettysburg of so long ago! When the battle had ended and the smoke drifted away, only the carnage and destruction remained, under the heavens of God that Pennsylvania sod, would be forever hallowed and stained!

All remained silent in <u>Heaven's Café</u>, humbled by history's review, and as the scenes drifted away we silently prayed for all the souls lost in this battle between the grey and the blue.

As I raised my head up, I looked to the generals each of them humbled by the tears on their face, and as they helped each other to rise I could see in their eyes, the question: "How did either of us wind-up in this place?" Now, the good book says, we are all God's children, regardless of the choices we've made, God forgives us our sins as we place our faith in Him, whether we wore uniforms of blue or of grey. Applause filled the air as those generals stood square and each offered his hand to the other, they left their sabers behind as a symbol for all time, and departed the café, not as soldiers, but brothers!

Well, I pulled up a chair and as I grew comfortable there, I contemplated all I had learned on this day, and as I leaned on the table I considered the case of Cain vs. Able, and sought the answers, here . . . in <u>Heaven's Café!</u>
