
COMPREHENSIVE PLAN

CLARENDON TOWN BOARD Meeting Highlights - July 2023



HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported working on water shut-offs after last billing and routine water maintenance. Big O has hooked into the public water with a 2" tap and a fire hydrant at 3753 Holley Byron Road has been replaced. There was one burial this month at Hillside Cemetery and the department continues to mow town properties. Lawn restoration from winter plowing is finished. Residents are using the town park a lot this year. The crew spent 2 ½ days working in the cemetery just prior to Memorial Day. Work share program has been projects with towns of Barre, Shelby and Byron and the Village of Holley. The fuel tanks at the highway garage have been painted. Tree stumps have been cleaned up at the cemetery and town hall. Superintendent Chalker reported that bulk tire disposal will most likely be handled by the county again this year. Bids to wrap the water tower pumphouse in metal were requested from five companies; two were received. Tim Gregoire of Hinds Road in Clarendon bid \$9700 and the Amish bid from Willow Run Construction in Lyndonville came in at \$4400. ARPA money will be used for this project. Kevin Johnson explained that the Amish typically have assurance, where the rest of their community will back them up if something goes wrong. Not insurance. Superintendent will ask. The Board approved the Amish bid of \$4400 contingent upon a current certificate of insurance being submitted. Superintendent Chalker explained the low level in our water tank on Memorial Day; that Monroe County installed a transmission line to LeRoy and when running in full force, it pulls water out of our tank at an alarming rate. It is balanced out now. Superintendent had opened our line from Barre to keep our tank at an acceptable level for approximately one and a half weeks. Superintendent confirmed that all the big trucks have kill switches on them, but pick-up trucks do not; NYMIR will be contacted to see if it's required on the pick-up trucks.

PLANNING BOARD REPORT

Chairman Dave Griggs reported that the Planning Board had no meeting last month.

HISTORIAN/HISTORICAL SOCIETY REPORT

Historian Melissa Ierlan reported that the Historical Society will meet tomorrow; that programs have been scheduled for July and August. Historian is working on one for September.

SUPERVISOR REPORT

In regard to the proposed District Court, Supervisor Richard Moy questioned Legislator Eick about procedure to place a referendum on the election ballot. Legislator Eick did not know the specifics; that the issue hasn't gone that far yet. At the next Association of Municipalities meeting, District Attorney Cardone will be there to speak about the District Court. Legislator Eick confirmed that he thinks a District Court would be a good thing; that it will be mandated someday. When he was on the Shelby Town Board, courts on the west end of the county were combined. Supervisor stated that the town courts will still be in operation as well; that he can't think of one good reason to have a District Court. Legislator Eick explained that some of the large issues that the towns handle now would go to the county instead. Cost was said to be a lot. Legislator Eick said that State funds and grant money will fund the District Court; Supervisor commented that the State has already taken funds away; what happens when that funding is gone?

CORRESPONDENCE

Supervisor Moy read aloud the News Release reporting that the Clarendon Highway Department has been awarded a full work zone package from New York State. Superintendent Chalker was commended for doing a good job with the application for award. The Town of Huntington has adopted a resolution requesting the State Legislature and Governor enact legislation to allow for a voter's identification process; Clarendon has done the same. The County Legislature sent a copy of its adopted Resolution authorizing distribution of Mortgage Tax Receipts to the towns and villages received between October 1, 2022 through March 31,2023. Also received was a check for Clarendon's share in the amount of \$15,462.88.

NEW BUSINESS

The Town Board did authorize an employee option for Roth IRA contributions for those contributing to the Deferred Compensation Plan. Discussion was held regarding the Joint Youth Recreation Commission and programs. Clarendon's representative is moving out of town and declined the January appointment. Highway Superintendent Chalker has a couple people in mind that would be good for the position and will contact them. A meeting of the Joint Youth Commission has been scheduled for June 22, 2023 at 3PM at the Village of Holley Offices. Councilman Allen Robinson will be the town representative and attend the meeting until someone can be found to fill the position.

Many years ago I put the following in my article. It was sent to me by a friend and I thought well worth repeating. A letter written to an insurance company: Dear Sirs: I am writing this letter in response to your request for additional information in block #3 of the accident report form. This explains the skull fracture, abrasions and broken collar bone which were listed in section #12 on the form. Slowed only slightly, I continued my rapid ascent not stopping until the fingers of my right hand were two knuckles deep in the abovementioned pulley. Fortunately, this time I had regained my composure and was able to hold tightly to the rope in spite of the excruciating pain I was beginning to experience. At the same time however, the barrel of bricks hit the ground and the bottom broke out of the barrel. Now devoid of the weight of the bricks, the barrel weighed about 45 pounds. As you might imagine remembering my weight, I began a swift descent down the side of the building. On the third floor, I again encountered the barrel. The fractured ankles, lacerations and broken tooth occurred at that point. Here my luck began to change slightly as the collision seemed to slow me enough to lessen my injuries when I fell into the pile of bricks. Fortunately, only three vertebrae were cracked. However, as I lay on the bricks in pain, unable to move, watching the empty barrel six stories above me, I inadvertently let go of the rope. Sincerely,

George was born in 1827 in Duchess County, NY. He was 24 years old when he came to Clarendon in 1851.


George was a blacksmith by profession. He married his wife Susanna and they had one child named Charles.

George entered military service in Clarendon and became part of the Company G, 151st Regiment. George was put in charge of that company's wagon train. The wagon trains carried supplies, food and ammunition and were horse drawn so it was only logical that George being a blacksmith was put in charge.


After he returned from the Civil War, George set up a blacksmith shop in the Honest Hill area of Clarendon.

George died in 1910 at age 83 and was buried in Hillside Cemetery.



DEC Officer rescues Injured Owl

Vern Fonda, an environmental conservation police officer, holds a Great Horned Owl that was injured The owl was in a quarry in Clarendon owned by Heidelberg Materials, Aggregates and Concrete (the former Hanson Aggregates site).



Quarry workers called the Department of Environmental Conservation to report there was an injured owl in quarry.

The owl was skittish of Fonda and quarry workers and was hiding in a crevice of the quarry. Fonda tossed a T-shirt at the owl, and the bird then clutched that shirt with its talons. Fonda picked the owl up using leather gloves. He put the bird in a cardboard box with ventilation. The owl was docile once in the dark cardboard box. The Great Horned Owls are nocturnal. This owl was probably disoriented from being out in the bright sunshine, Fonda said. He then took the owl to Robert Humbert, a wildlife rehabilitator in Wolcottsville. Fonda speculated the owl was hunting for mice and likely flew into a stone wall, injuring a wing. Or it may have hit its head and was concussed. Fonda met the quarry workers from the South Holley Road entrance to the quarry. Fonda said he expects the owl will be released by the wildlife rehabilitator after regaining strength. The rehabilitator has enclosures and will feed the owl while it recovers, Fonda said.


