On Fourth Section Rd (NYS Rte 31A) east from South Holley Rd. on the south side to Parcel 99.-2-37.4 and on the north

Re-designate current RR district bordered by Lake Rd., Powerline Rd., So. Holley Rd. & the Village of Holley line as RA. Parcels on corner of Hall Rd. & NYS Rte 31A change from RR Zoning District to BC Zoning District.
