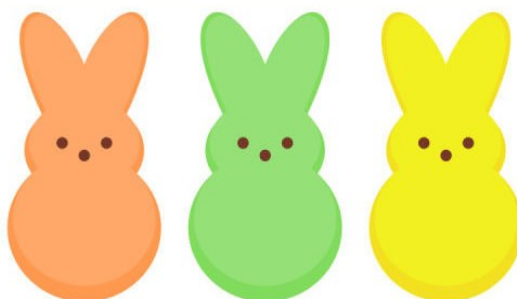

## **Memories - My Sisters on the Wiles farm**

*By David R. Griggs as told to him by Joan & June Griggs*

As I have grown older I have spent some time contemplating my life. One of my deepest regrets is not taking the time to find out enough about my family's history. In an effort to chronicle some of those missing memories I turned to my sisters to try and fill in some of the blanks of their early childhood days living on a small farm in the southern tier of NY. Our father Manfred, was born in Pike, NY and our mother Irene was born in Cleveland, Ohio. At one point they lived in Baltimore, Maryland where the girls were born and later in Washington D.C. From there they moved to a small farm in Freedom NY where these recollections begin. While living in Freedom Dad worked in a casket factory and trapped Muskrats for their fur. He bought a calf that they named Becky and a pig they named Bucky. One of my youngest sister June's memories from the Freedom farm was dad coaxing the pig into the kitchen (he must have had a thing about animals inside, I remember years later when he led my horse up the steps and into Burt Neghus's store). My older sister Joan remembers Dad feeding the pig a warm mash slop from a bucket and the pig following him around like a puppy. Somewhere around 1942/1943 the family, along with Becky and Bucky, now fully grown, moved from Freedom to our Step-grandfather, Art Wiles, farm in Hume/Fillmore, NY located across the river bridge (Lattice bridge) up on Cronk Hill/Dutch Hill Road, Joan was 8 and June was 5. The farm house was about as basic as you could get. It had no running water, no indoor plumbing (toilet), no electricity, and no central heat. They carried all their water in from a spring, heated the house with a big old black wood stove, for lights they used kerosene lanterns and either a chamber pot or an outhouse was used for sanitary necessities. June remembers them taking their baths in a wash tub next to the wood stove. Laundry was done by hand on a washboard with water heated on the stove then hung out to dry, ironing was accomplished using a heavy cast iron also heated on the stove. There were numerous fruit trees on the farm; pears, plums, apples, cherries, and they ate fresh fruit when in season. They were also pretty neat for climbing. The farm house itself consisted of a bare enclosed porch entry where a cream separator was located (June said the separator was always a mystery to her as a child, you poured milk in the top and by turning the crank milk came out one side and cream out the other), from there you entered into the big kitchen with it's large cook stove. There was a table adjacent to a large window where they would look out to see deer. June remembers setting there in the evening and either Dad or Mom dimming the lanterns so they could watch the deer come to the apple trees lining the roadway. There was a large living room where the girls used to line up Dominos to push down later and a couple bedrooms. There was an upstairs but it was used for grain storage as far as anyone can remember. Some of the memories the girls had of the Fillmore farm included a runaway horse and wagon incident where they were sitting in the wagon while my Dad was fixing fence. The noon whistle blew and the horses recognizing that whistle took off for home and the barn. The bed of the wagon was only loose planks and on that very fast and bumpy ride they separated and June fell through landing on the ground between the wheels while the wagon proceeded on to the barn.

While listening to Swing Music, attendees will be able to sample wines from area vineyards, shop with local farmers and entrepreneurs and have fun with friends. In addition to the opportunity to win the huge basket on display in the library starting April 2, attendees can participate in a 50/50 drawing, take pictures at a themed selfie station, and hope to win some of the other wonderful door prizes. This sell-out event, held annually on the last Friday in April, provides funding for the library's summer reading program for both children and teens. This year Kenne's Cakes and Confections (Brockport) will provide samples of their sweet treats while Tripleberry Farm (Kendall) will bring their locally made jams and jellies and goat-milk soap. Deputy Supervisor Allen Robinson welcomed all present and introduced Sandra Shaw, Director of the Community Free Library in Holley. Ms. Shaw presented information about the upcoming wine tasting event to be held on April 27<sup>th</sup> at the library. There will be four wineries, two farms and many businesses represented. This year the event will have swing music and looks to be a lot of fun. Tickets go on sale April 2<sup>nd</sup> and the money generated goes toward the summer reading program. **HISTORIAN/HISTORICAL SOCIETY REPORT** Historian Ierlan reported the contract for the Hillside Chapel is underway. We met at the Chapel on Monday to talk about the details. The mason just completed the inside work and once the weather gets better he will begin the outside masonry work. April 18<sup>th</sup> at 7PM is the first Historical Society meeting for the year. Matt Ballard, County Historian, is presenting the program; the topic is: Stories that Kill, Infamous Criminals in Orleans County History. I have been asked by Tim Archer, the service learning teacher at the Albion School District to attend a student seminar called "Service Above Self" on Thursday. This will be an opportunity to talk to kids about the reasons why adults and others volunteer in our communities.

Yesterday a package came from a former resident, Fred Miller. It contained bound copies of the Holley High School yearbooks from 1949-1954. They will be available for people to look at here at the Town Hall. Mr. Miller has been very generous through the years with contributions of money to the Historical Society as well as a complete set of microfilm of the Holley Standard newspaper which has been shared with many people via FultonHistory.com. Connie Gaines has donated several items and the latest is a scrapbook from a former Holley resident with many clippings of local events. I have even had the opportunity to send wedding invitations to people from their parents' wedding that we kept in the scrapbook. I also donated an 'entry ticket' from a 1948 event held by the Orleans County Boots & Saddles Club. Great Stuff! On March 7<sup>th</sup> I visited the 'Holley After School Friends' group in the elementary school and showed them many old postcards from our area. It was fun to see the kids look at places they are familiar with now and their reaction to what it looked like a hundred plus years ago.

**SUPERVISOR REPORT** Deputy Supervisor Allen Robinson acknowledged a resolution from Chenango County opposing the Empire Forests for Future Initiative (expansion of the Forestry Exemption). A NYSIG representative will be sending information about an inter-county meeting. Deputy Supervisor Robinson gave information of up-coming training opportunities for Municipal Land Use Officials. Heritage Wind, LLC has sent Notice of Preliminary Scoping Statement for the Heritage Wind Project; 200 megawatt major wind energy generating facility in the of Barre. The Town of Yates is not in favor of a project but it seems that Barre is. It will include 20-37 Turbines. A seven member Siting Board will be appointed to review the project for environmental compatibility and public need; five will be governor appointed, two will be local representatives. The Village of Holley has been awarded grants for replacement of sidewalks and waterlines. Surveying is underway.

**CORRESPONDENCE** The Orleans County Department of Personnel and Self Insurance has sent notice of Safety Training. Annual required training is the Right to Know and Workplace Violence for all municipal employees. Highway employees will also attend equipment safety training. Dutchess County has sent a thank you to the town for adopting a 'Think DIFFERENTLY' resolution, encouraging the community to embrace individuals with special needs. Orleans County Youth Bureau has sent a request for nominations for several awards presented annually to young people who have performed an outstanding service for their community and/or have assumed an extraordinary role within their family. Historian Ierlan will look at the different awards and suggest nominations. NYMIR has sent the return of annual underwriting earnings for the year 2016 in the amount of \$55.00. PathStone Corporation has sent notice of new contact information and opportunities that are offered through NYSEDA's Assisted Home Performance Program for the Finger Lakes Region. Free home energy audits, help with home improvements, and matching grants are available for household income eligible homeowners, renters and landlords.

**OLD BUSINESS** The Board authorized the rate per 1000 gallons of water for Water District No. 1 (Thomas Estates) at \$4.80.

## TOWN BOARD MEETING HIGHLIGHTS March 2018

The Board determined that parcel ID 120.-1-64 on the corner of Holley Byron & Munger Roads to be a hardship parcel in Water District No. 13 and will have a \$10 debt service charge. The parcel is completely in the wetlands and can never be developed as a 100' buffer is needed from the wetlands; not possible. The Board adopted a SEQR Resolution for Water District No. 13 and a resolution authorizing election inspectors to work the special election for WIBA 12 and WD 13. At the Hillside Chapel, the large window has been taken out in a couple of different pieces; the window and wood will be repaired offsite if possible. The sashes under the large window are mush! The contractor is trying to match glass colors. It will be boarded up with painted wood during the process. The Contractor has been in business almost 30 years and hasn't had one bad comment about him. This year the Medina Historical Society is planning a bus tour and will stop at Hillside. It will be dark in there, but can still be shown. Unused sick days for medical coverage was moved to the April agenda.

**NEW BUSINESS** The Board accepted Dan Jones proposal to mow the Pioneer Cemetery on Glidden Road for the 2018 season. Kevin Johnson represented the Clarendon Lions Club and requested permission to put a "Little Free Pantry" at the Town Hall. Mr. Johnson provided specs of the structure and an information sheet about the project. It is for neighbors helping neighbors; people will be invited to donate food and small items to place in the pantry and to take from there items needed; put in – take out was the concept given. There would be no hours of operation. Mr. Johnson stated that other pantries have seen the items gone in a day. Mr. Johnson requested permission to construct the pantry on the east side of the building off the driveway. It was suggested that the Town contact the insurance company prior to authorization regarding liability. Deputy Supervisor will contact the insurance company. This will be on the April agenda. The Board adopted a resolution in opposition to the free tablet program for prisoners and Karen Bradshaw was appointed as an Alternate Member of the Clarendon Planning Board; term to expire 12/31/2018. The Board authorized an upgrade through Spectrum to the Town Hall phone and internet services.

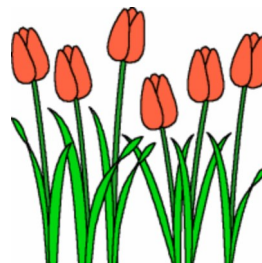

**Memories** ..... *Continued from page 2...*

Luckily she wasn't hurt but she sure was shaken up and scared. Dad was going to whip the horse but my sister Joan stepped in to stop him, she figured the horses wanted their lunch too. Another memory occurred during butchering season. Now normally the girls weren't allowed to be out with the men while they were working but on this particular occasion they were sitting on a fence watching Dad prepare to butcher a small hog by sticking it's throat to let it bleed out prior to butchering, they remember it squealing and running about until it fell over. Not a pretty sight or sound and not one of their favorite memories but it was one of the things done in those days to put food on the table. They also told the story of a puppy getting lost over a steep gully across the road. The girls were too young to climb down so they ran to the house for Mom, she ended up having to go down to rescue it making two little girls very happy. Other memories included climbing trees, Joan laying down with a bunch of baby skunks born under the barn, knocking out a wall in the barn and seeing a gazillion mice scattering about, poking sticks into the molasses barrel and sucking the molasses off to eat with a piece of salt knocked off from the salt block. June remembers sitting along the bed of a truck or wagon with her little Orange lunch pail eating peanut butter and crackers. It was potato season and they were having lunch before going out to pick potatoes with Mom. One of the few stories I remember my Mother telling was her and Dad going out for walks in the evening. Dad would take a saw or axe and would chop logs into pieces which they would then carry back with them for firewood. Two memories in particular tend to demonstrate the innate ability of animals to detect the absence of a threat particularly where young children are concerned (my horse Pardner was like that around kids). The first involved the girls playing in the pen with a sow and her new litter of baby pigs oblivious to the fact that mother sows can be very protective of their young. Luckily for them, Mom had coaxed them out of the pen before the sow changed her mind. The second was having a normally skittish horse named Kit who loved to kick people allowing the girls to crawl under his belly and between his legs to curry him. As June described it; *"We brushed and curried that horse top to bottom, under belly between his legs and his rump with nary a ripple"*. They were coaxed out from danger this time by Dad. Somewhere along the line there was a bitter disagreement between my Father and Step-grandfather over unpaid wages owed to my Dad and the family left the Wiles farm in late 1943. They moved into a house on Wells Street in the town of Hume NY across from the old school house. That family estrangement was severe enough that while we only lived one mile away from my Grandmother and Step-grandfather my entire life we hardly ever saw them after that. I can't remember them ever coming to our house and only remember visiting my Grandmother on my own on very rare occasions. I was born in that very house in January of 1944. One of the more vivid memories my sisters recalled of moving to the new house was my Mother talking about the joy she had in the discovery that there was not one, but two water pumps inside the house, one at the sink for drinking and cooking and one on the back porch from a rain fed cistern that was used for laundry. While there was still an old outhouse on the property there was also indoor plumbing. It's hard to comprehend getting excited today to have running water and a sanitary system inside the house. It shows you how important some of the little things in life really are, things that we so often take for granted in the modern world of today. Another major regret I have is the lack of any information of how our parents met or how they got from Pike and Cleveland to Baltimore and Washington, or what they did for a living (I vaguely recall my Mother mentioning working as a sales clerk in a department store), no idea what my Dad did. He learned the Mason trade from my Mothers step-father somewhere along the line but again we have no idea where or when. If any lesson is to be learned from reading these childhood remembrances it should be the importance of finding out these family memories and documenting them for future generations.....

### RECYCLING

Place all recyclable materials inside the green recycling bins provided by the county. All recyclables can be placed out weekly inside the recycling bin on the same day as trash pickup. Please place recycling bin away from garbage so driver can see it.

### GARBAGE

The equivalent of 6 bags or cans of normal municipal solid waste including garden and yard waste, ashes (cold ashes only), plaster, stones, bricks and building materials.

- Place garbage in 20 or 30-gallon watertight cans with covers and handles, or (3 mil minimum) plastic bags. Do not use shopping bags. Limit of 60 pounds per container. Securely tie bundles of brush and building materials in lengths of no longer than 4 feet and within a 60-pound limit.
- DO NOT INCLUDE: tires, pesticides, oils, solvents, flammable liquids, explosives, animal carcasses, fecal matter, industrial waste, other regulated hazardous waste or building materials left by a contractor.
- E-WASTE (MICROWAVES, TELEVISIONS, and COMPUTER equipment)** will no longer be picked up. Please take it to the nearest Electronic Recycling facility... Open 9am-2pm Monday - Friday

Albion- Orleans County Highway Garage- 225 West Academy Street, Albion.

Holley- Town of Murray Highway Garage- 3840 Fancher Road, Holley

Medina-Town of Shelby Highway Garage- 4062 Salt Works Road, Medina.

### FOR COLLECTION

Place garbage and recyclables at your roadside, within 5 feet of the road, before 6:00 am on your pickup day. If you have a ditch in front of your property, place garbage and recyclables between the road and the ditch.

- Garbage and recyclables will be collected on the same day in separate trucks, at different times during the day.

### LARGE ITEMS

A large item is any refuse that cannot be placed in cans or bags easily. **ONLY ONE LARGE ITEM WILL BE PICKED UP EACH WEEK AT THE ROADSIDE.** Refrigerator doors and shelves must be removed and the customer must call Modern Disposal (# below) on the **FRIDAY** prior to their scheduled pickup day. Large items will be collected on the same day as regular service and placed in the compactor truck. These items shall include, but are not limited to furniture, mattresses and box springs, carpets, appliances, Christmas trees, or carpeting (rolled and tied 4 foot lengths).

### TIPS

Paint Cans- the lid must be off and the cans are to be set next to the trash can so the driver can see that the contents are dry. Clumpable cat litter can be used to dry up any contents prior to disposal.

Cold Ashes- must be cold and contained either in a bag or a cardboard box so the ashes do not go airborne as they are placed in the truck.

Medical Syringes- Medina Memorial Hospital takes them on Saturday mornings. Please do not dispose of these in the regular trash.

### HOLIDAY SCHEDULE

New Year's Day – Memorial Day – Independence Day – Labor Day – Thanksgiving Day – Christmas Day. If your collection day is on or follows any of these holidays during the week, then your collection will be one day late.

### HOW TO GET A RECYCLING BIN

A green recycling bin may be purchased for \$7.00 each from the County Real Property Office in Albion at Courthouse Square. Call (585) 589-5400. If you have built a new home, you are entitled to a free bin. Just present your property tax receipt, showing that the garbage collection fee has been paid, to the Real Property Service Office.
