# **CLARENDON TOWN BOARD - Meeting Highlights July 2019**

Oriden Power representatives Seth Wilmore, Director of Sites and Permits and Michael Berlin, Director of Development introduced themselves to the board and informed they are looking at a solar project proposed on Kevin Wolf's farmland, near the power lines on South Holley Road. This company is sponsored by Mitsubishi who is in the gas business and now looking into renewable energy. Oriden's office is in Pittsburg, PA and only a four hour drive to Clarendon. Oriden wants to be present for the project from concept into construction and operation. All work by the power company would be done by in-house staff. Concept includes site selection, origination, environmental regulatory permitting, and interconnection process, power purchase agreements, project development, project financing. Power Production includes engineering, procurement, construction and operation and maintenance. A development timeline was presented showing construction for this project to likely be in spring of 2021; plant online in the fall/winter of 2021. It was presented that the site selected would have onsite interconnection, no tree clearing, no stream crossings or wetland impacts, sufficient acreage to minimize project visibility, is in Orleans County Ag District 1 has easy ingress/egress and low housing density. This 20 MW ground mounted solar project is being called Farwell Solar. It was explained that Oriden focuses on smaller community scale projects of 5-20 MW with a single land owner; that this type of project is quicker to completion (single season 5-8 months for construction). It was stated that Oriden would cover any penalties that will be assessed from pulling the property out of the Ag District for the project. Life expectancy of a solar power plant as the one proposed is said to be thirty to thirty-five years. Planning Board Chairman Dave Griggs suggested all board members go and view the solar farm on Whittier Road in Ogden. There is a double row of ten foot trees around the project for screening. Oriden representatives informed that ten feet is minimal for creating shade on the panels and is quite doable. The minimum acreage for such a project is 30-40 acres. There is no fire risk, as is no battery system.

#### HIGHWAY/ WATER DEPARTMENT REPORT

Superintendent Larry Swanger reported helping Murray and Barre with paving and Albion with shoulder work. The dirt section of Brown Schoolhouse has been paved with the free grindings from the state. Five other towns helped pave Mansfield and the Brown Schoolhouse Road. The Highway Department closes each year for the week of July 4<sup>th</sup>. During that week, a resident called about water in the yard. Superintendent Swanger went to the site and found a leak in the service line between the road and curb box on South Holley Road, near Route 31A. Water meter readings will be done next week.

SD 19-07, John DeFilipps, pre-conference for subdivision for merger (11.125 acres) tax id# 99.00-1-47.1 of property owned by Bruce Wohlers. One minor issue noted (missing survey pin). Applicant requested to move to a formal application. Motion was made, seconded and approved to move to a formal application. A motion was made, seconded and approved to declare this a minor subdivision for SEQRA purposes. A motion was made, seconded, and approved to approve the subdivision contingent upon merger with properties of John DeFilipps tax id# 99.00-1-47.2 and verification by the OIO that the missing pin issue is corrected. SP 19-05, Gary Germeo, formal application for a Special Use permit for storage facility, Hall Road, tax id# 99.-2-37.4. Chairman Griggs reviewed the letter from the Orleans County Planning Board indicating that the TOC could proceed with final action on this application. A motion was made, seconded and approved to grant approval SP 19-05 contingent upon conditions set on the Special Use Permit. The next regularly scheduled Planning Board meeting is 7:00 PM, July 23, 2019 at the Town Hall, 16385 Church Street.

# SUPERVISOR REPORT

Supervisor Richard Moy reported that the Water Improvement Benefit Area No. 12 project will go out to bid on August 15, 2019. A pre-bid meeting will be held August 9, 2019.




# Town Board Meeting Highlights Continued from page 2

2019/2020 Funding Availability for the Affordable Home Ownership Development Program (AHODP). Notice has been received of a Regional Safety Seminar including Sexual Harassment & Discrimination provided by the Comp Alliance and NYMIR Insurance. New York State has sent payment of \$1,511.53 for DOT Snow & Ice 2018/2019 adjustment. New York State Department of Taxation & Finance Office of Real Property Tax has determined the Final State Equalization Rate for the 2019 Clarendon Assessment Role to be at 100%. New York State Assembly has sent notice of 2019/2020 CHIPS Aid designated for Clarendon in the amount of \$150,377.78.

# **NEW BUSINESS**

The Board scheduled a workshop meeting to discuss Solar Farms for inclusion in the Zoning Ordinance; to be held August 6, 2019 at the Town Hall, immediately following the workshop meeting scheduled at 6 PM regarding the Employee Handbook. Supervisor reviewed that the Tentative Budget for 2020 needs to be presented to the Town Clerk by 9/30/2019. A workshop for the 2020 town budget was scheduled for September 18, 2019 at the Town Hall: to begin at 6:00 PM. Discussion was held regarding the National Grid Energy Savings Plan quotes to change the Town Hall and Highway Garage to LED lighting. Cost for Town Hall change would be \$1,993.40 and it would take eight years to save \$260.90. Cost for the Highway Garage would be \$3843.81 and it would take 3.4 years to save \$1,491.25. All in agreement that it would not be worth it to have the Town Hall changed over to LED lighting; change-over at the highway garage was approved.

# Híllsíde Cemetery

For the people who are interested in genealogy sometimes information you uncover is slightly incorrect. Take this headstone in Hillside cemetery for instance.

**Mary T. Crannell** was born April 4, 1846 and she died June 10, 1847. She was initially buried elsewhere and as you can see by the burial transit permit her remains were brought to Hillside Cemetery and buried on August 16, 1912. The problem is that the transit permit has her name spelled Mary Thressa Crandal.



The website findagrave.com shows the name spelling as Mary Therese Crannell .



Same individual, different spellings of the name. The person who made out the burial transit permit probably never gave a second thought to the spelling of the name. Many times you can see on any documents in history that are handwritten, names were spelled one way or the other based on what the person heard who was recording it. (census takers for instance) This is a good tip for anyone doing family research, check different spellings of any name you are looking for because there is a strong chance it could be right there but spelled wrong and you could be missing out on an important piece of your research.



# Protect Your Family from Tick Bites this Summer!

With the warm weather here and more opportunities to spend time outdoors, it's important to remember these tips to prevent ticks from affecting your summer. Be sure to protect yourself, pets and your property from these pests.

- Wear light-colored clothing with a tight weave to spot ticks easily.
- Wear enclosed shoes. If wearing long pants and sleeves tuck your pant legs into socks or boots, and shirt into pants.
- Check clothes and any exposed skin frequently for ticks when you are outdoors.
- Avoid dense woods and bushy areas, as tick climb upwards to find hosts.
- After going indoors at the end of the day, do a full-body tick check and try to bathe or shower within two hours of returning to more easily spot ticks that may be on you. Be sure to check your pets as well!
- In your yard, reduce shady and damp areas and clear any leaf litter or seeds from the ground.
- Replace plants that deer love to browse with deer-resistant plants. Consider installing a deer fence to help reduce deer from dispersing ticks.

An extremely effective way to kill ticks on exposed clothing is to tumble the clothing in a dryer set on high heat for at least 10 minutes.
