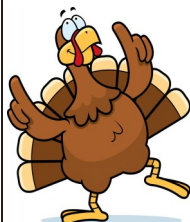

## CLARENDON TOWN BOARD - Meeting Highlights October 2019

**Public Hearings were held** prior to the regular meeting; regarding the following: Town of Clarendon Local Law No 5 of 2019, A Local Law to Change the Grievance Day for Assessments in the Town of Clarendon; Town of Clarendon Local Law No. 6 of 2019, A Local Law Imposing A Moratorium on the Commercial Solar Uses in the Town of Clarendon; Town of Clarendon Local Law No 8 of 2019, A Local Law to override the tax levy limit established in General Municipal Law 3-C. No negative comments were heard at the public hearings. Some spoke in favor of the moratorium on commercial solar uses.

**Seth Wilmore of Oriden Power** spoke to the Board in between public hearings on October 15, 2019, and gave an update of its proposed Solar Project on South Holley Road; Kevin Wolfe property. Mr. Wilmore reported its application to NYSERDA in September 2019; all the information is on the NYSERDA website for public review. Oriden intends to have an Open House in Clarendon in December to introduce its plan; typically held from 6:00–8:00 PM at the local fire hall. They will give a small presentation and remain available to answer resident questions. Posters informing of the Open House will be given to display. Mr. Wilmore was given the contact information for using the Firemen's Recreation Hall. Mitsubishi is sponsoring the Oriden Power 20 megawatt solar ground mount project. Supervisor explained that the town currently has no large scale solar laws in the town zoning; that the proposed 6 month moratorium will give the town opportunity to review different laws already in place and compose one for Clarendon. Supervisor reported that National Grid determined the capacity in the regular electric lines is not even one megawatt, therefore community solar projects are non-existent. Supervisor has requested the capacity capability on South Holley Road and is still waiting for a response. NYSERDA is setting up a tour of a solar facility; Supervisor is arranging for a school bus to meet residents at the Town Hall for those who want to go. It will be advertised when we have the information.

### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Larry Swanger reported helping the Town of Barre with paving. Shoulders were installed on Jackson Road past Lusk. The third roadside mowing is almost complete and New Guinea Road has been graded. Third quarter water readings have been started. Superintendent Swanger reported that Jamie has been mowing the cemetery completely with zero turn; that the John Deere lawn mower purchased in 2018 for use in the Hillside cemetery only has seven hours on it. Superintendent would like to trade it in for a John Deere Tractor Model 1025R (without mower deck) for the highway department; it would help with cemetery foundations. Councilman Major in favor of purchasing the tractor and to keep the 2018 mower to possibly work on other cemeteries. Town Board gave approval to purchase the new tractor and keep the 2018 John Deere.

home, New Guinea Road, tax id# 119.-2-55.2. No issues were noted, applicant requested to wave pre-conference and proceed to formal application. A motion was made, seconded and approved to change the agenda from a pre-conference to a formal.

A motion was made, seconded and approved to approve site plan review for building lot approval contingent upon verification by the IOI of perc test. **SP 03-04**, Special Permit renewal, Yuri Odeychuk, 4355 Holley Byron Road, Alternate Energy system, wind, private. Inspected, fee paid, no outstanding complaints. A motion was made, seconded and approved to approve renewal. **SP 17-01**, Special Permit renewal, Gary Casale, 5278 Holley Byron Road, GMC Industries. Inspected, fee paid, no outstanding complaints. A motion was made, seconded and approved to approve renewal. **SP 19-29**, Jeremy VanAmeron, 4530 Holley Byron Road, Motor Vehicle Repair (addition to existing mixed Use Occupancy), County Planning Board referral. CPB had no issues with special use permit as submitted. A motion was made, seconded and approved to grant final approval to SP 19-29.

### CORRESPONDENCE

The Town received \$24,188.66 from New York State in aid through Pave NY CHIPS funding. Notice has been received from the Orleans County Planning Department of upcoming training opportunities. Planning Board members Dave Griggs and Russ Bosch will attend the session on 11/15/2019 in Batavia. Notice has been received from Niagara County of upcoming Land Use Training for local officials. The Orleans County Farm Bureau Annual Meeting will be held 10/17/2019 at the Shelridge Country Club in Medina. The Orleans County Board of Elections has sent information on the November 4, 2019 general election. Voting hours will be from 6:00 AM until 9:00 PM. The Falls Rail Road PILOT payment for 2019 has been received in the amount of \$32.47. The annual training school and meeting offered by the Association of Towns will be February 16-19, 2020 in New York City.

### OLD BUSINESS

The Town Board authorized the agreement as presented by New York State for the Snow & Ice Agreement for 7/1/2019 through 6/30/2024. Local Law No. 5, A Local Law to Change the Grievance Day for Assessments in The Town of Clarendon; Local Law No. 6, A Local law Imposing a Moratorium on the Commercial Solar Uses in The Town of Clarendon and Local Law No. 8, A Local law to Override the Tax Levy Limit Established in General Municipal Law 3-c were adopted. Resolutions were adopted to Override the Tax Levy Limit for all the special districts; Clarendon Fire Protection, WD 1, WD 2, WD 3, WD 4, WD 5, WD 6, WD 7, WD 8, WD 9, WIBA 10, WIBA 11, WIBA 12, WD 13. The Board authorized reassessed mowing and water charges to be put on January 2020 town/County Tax bills for charges in arrears from August 2019 billings and/or prior billings with an account balance due totaling over \$20 remaining unpaid on October 31, 2019 be added to the January 2020 town/county tax bills with an additional \$100 penalty. The Board approved to continue the Clarendon Lions Club Little Pantry at the Town Hall with continued monitoring of food in the summer and warm weather months.

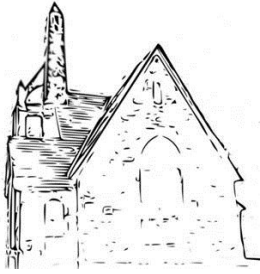

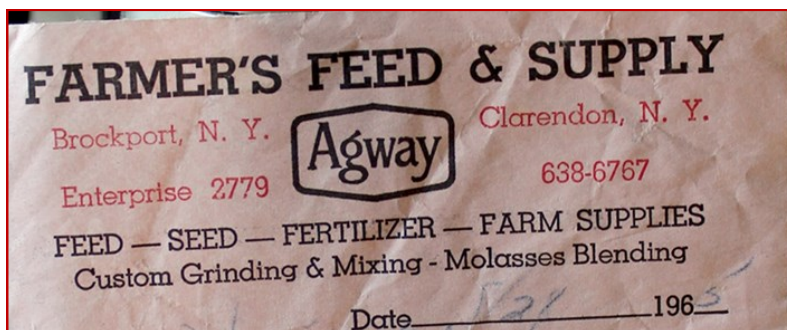


## Hillside Cemetery

*Tracy Smith*  
1907 - 1984

Born in Rushford NY and moved to Clarendon as a young man to work for George Keople in his cheese factory. He was a cheese maker for 11 years. Cassius Webster and Tracy Smith bought the Housel feed mill and G.L.F. franchise in 1939. It was known as Farmers Feed and Supply. It was operated by Smith for 25 years. The store has passed through several owners since those days and currently is owned by Brandon St. John who has done a lot of work to the building and turned it in to Clarendon Corners Mini Storage. St. John recently invited the town historian to the barn on the property and donated many items which are on display at the town hall.

Many a Clarendon resident worked in the feed store over the years. If you notice on the receipt from 1965 it says **Custom Grinding & Mixing- Molasses Blending**. Cecil Moore told me a story several years ago when the building was being renovated that he once forgot to close the valve on the mixer and that molasses had run out and gone clear down Rt. 237 that night! That must have been a sticky mess for sure.

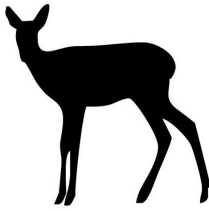

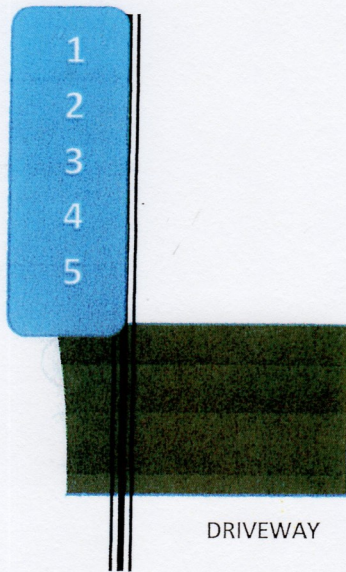
