## CLARENDON TOWN BOARD Meeting Highlights Summary March 2020

Due to the Coronavirus Pandemic, office staff has been working behind locked doors; the meeting was closed to the public to help stop the spread of the virus.

#### HIGHWAY/WATER REPORT - Tracy B. Chalker, Superintendent

Superintendent Chalker reported little plowing and salting this past month. The crew has patched a lot of pot holes, done some sign repair and trimmed trees overhanging the roads. The highway department also helped the county with tree removal. Road kill has been picked up and vehicle maintenance done. Superintendent intends to again have free wood chips and will move the pile up front at the garage when ready. Superintendent Chalker went to Albany for the annual lobbying efforts for the CHIPS program; there were over 750 highway superintendents in attendance. The monies looked good until this Coronavirus hit; now the state budget is unknown. There are between 500-750 tires to be disposed of at the highway garage. Superintendent is looking at disposal options; has put an ad on Craigslist to see if any area farmers would like them; the highway department will deliver them; no response yet. It was confirmed that the town crew rids the town roads of road kill; the state has a contractor to clean up the state roads, but if it is a mess and someone calls to report it, the town will go out and pick it up.

#### PLANNING BOARD REPORT - David R. Griggs, Chairman

Chairman Griggs reviewed that he had provided board members a summary of the last Planning Board meeting regarding the county communication tower. Chairman Griggs submitted the following written report: 02-25-2020 (Regular meeting) SD 20-02 Pre-conference Robert Arnold, New Guinea Road, tax id# 119.-2-55.2, for a one (1) lot subdivision and building lot approval. A motion was made, seconded and approved to declare this a minor subdivision for SEQRA purposes. No issues noted, a motion was made, seconded and approved to waive the pre-conference and move to formal application. No further action taken pending receipt of proper survey map for the subdivision portion of this application. SP 07-001 Chad Richey, Autumn View Apartments, 5395 Upper Holley Road. Fee paid, Inspected, No outstanding complaints. A motion was made, seconded and approved to approve renewal. 03-10-2020 (Regular meeting) SD 02-03, Preconference for a site plan review, Orleans County Emergency Management Office, Radio Technologies request for a 150' monopole radio tower. After significant discussion two critical areas of concern were identified that required reconciliation before this proposal could move forward. The applicant was advised they would need to submit an application to the Town of Clarendon Zoning Board of Appeals to grant two (2) variances before any further action could be taken. SP 96-005, Special Permit Renewal, Nancy Curtis Caswell, Pet's Galore Grooming, 4880 South Holley Road. Fee paid, inspected, No outstanding complaints. A motion was made, seconded and approved to approve renewal.

#### SUPERVISOR REPORT - Richard H. Moy, Supervisor

Supervisor Moy confirmed that the board did address the issue of parttime to full-time employees in executive session at the 2/27/2020 workshop meeting. Supervisor Moy read aloud the board's action that has been added to the Employee Handbook; that 'Benefit Employment Start Date' will apply to employees that have been hired on as a full-time employee after working part-time for the Town. Benefit Employment Start Date is meant only for enhancing retirement benefits and current/future vacation eligibility.

#### CORRESPONDENCE

Notice of Submission of Application for the Heritage Wind Project in the Town of Barre has been received from Heritage Wind, LLC. A Local Government Lobby Day was scheduled for March 23 in Albany; for Supervisors and Mayors to be a collective voice of New York's local governments during the state budget negotiations between the state legislature and the governor. This has been cancelled due to the Coronavirus pandemic; Supervisor had intended to go. Association of Towns has sent notice of its 20th Annual Finance School sessions. Supervisor Moy will attend May 21 and 22, 2020 in Geneva, NY. Supervisor took notice of the last session to be attended regarding Managing the Highway Fund; roles of the Town Board and Highway Superintendent. The Town has received a check for \$18.03 reflecting our share of distribution of recovery to New York Local Governmental Entities in relation to the DRAM Antitrust Litigation. The New York State Department of Environmental Conservation has received notice of complete Notice of intent for coverage for construction of Water District No. 13; SPEDES General Permit. Town of Sweden has sent copies of Legal Notices for scheduled public hearings; for approval of 3 lot 'Morich' subdivision; Solar Park Energy 12, LLC's application for subdivision, site plan and special use permit approval for Solar Farm on West Sweden Road north of White Road; application for an area variance due to nonconforming front setback of a preexisting house.

#### OLD BUSINESS

Discussion was held regarding Nick Penna's renewal of lease agreement with Clarendon to farm approximately 10.4 acres of town property behind the Hillside Cemetery; renewal proposed for five years at a \$50 annual payment increase each year of the lease. Concern was expressed about the county radio tower project proposed in the same vicinity adjacent to where Mr. Penna farms; that Mr. Penna should be made aware. It was also stated that garbage is burned there by the trees; that refuse is being stored on the property, mostly brush and boxes left over from public market transport/sales of his product. Councilmen would like to see no burning of any materials and no storage of refuse materials on the property be added to the lease agreement. Supervisor will speak with Mr. Penna regarding the tower and the proposed amendments to the lease. Item will be on the April agenda.

Councilmen Marc Major and Bruce Hovey agreed to serve on the Committee for this Comprehensive Plan Review/Update; Also Bill Fox, Planning Board member and Chris White, Clarendon resident. The Committee is in need of a Chairperson. It was suggested that Assessor (to retire 3/31/2020) Cindi Davis be asked to chair the committee. The Board scheduled a Solar Workshop Meeting for 5/6/2020 at 6:00 PM at the Town Hall, 16385 Church Street, Clarendon, NY.

Supervisor reviewed the Governor's proposed Article 23 as part of his annual budget : Accelerated Renewable Energy Growth and Community Benefit Act. This would dismantle the State's Article 10 process which required electricity generation projects of 25 megawatts (MWs) and larger to go through a multi-staged and

**JOHN** - He stood at our front door, an old man dressed in his good clothes - a fairly new set of denim coveralls, smelling only faintly of the farm. "Mr. Welch," he addressed me, "I'm John McAllister." The formality and deference were in no way deserved - he was many years my senior and a well-established member of the community. I was a brash young newcomer who lived up the road from him, in a house he still thought of as the "LaZize" home, who predated the people we bought it from by many years.

I had a sign for my new hydraulic shop on my pickup truck and he needed some seals for a leaky cylinder. I was glad it was something I could help him with, and get to know him. His sister, Kay, had stopped by shortly after we moved in, to introduce herself and welcome us, as she did for everyone new. I delivered the seals to McAllister Drive, a small dirt road off the state highway which ends at their old barn. I think John and his sister had lived there since they were born. The rest of their family had married and moved away; their parents had died. They were still listed in the phone book under their mother's name. I was invited like company into their weather-beaten but comfortable home. Nicer neighbors you couldn't find.

Another time I got my truck stuck trying to haul some firewood up from the back lot. It couldn't make it up the hill with the heavy load of logs. I was unloading the wood so I could drive it a little closer to the road when John drove by on his big Oliver tractor. "Put that wood back in," he ordered, "and I'll pull you out." He hooked on his big chain and dragged my truck up out of the lot like it was a toy on a string! He and Kay took being good neighbors seriously. I think they considered it their Christian duty. But we never felt obligated to them for a kindness - that's not why they did it.

Once I needed fertilizer for the garden, and drove my truck over to John's to ask for some manure. It was one thing he had in abundance! "Sure," he said, "just back your truck over beside the barn. There's a manure fork inside." The giant pitchfork he used held about 50 pounds per forkful I think, and I struggled to slowly load the truck. He took pity on me and came over to help. The strength in his huge hands was twice mine, and he had the truck loaded in no time. I felt like the kid up the street, but John said nothing to embarrass me. He was probably used to being stronger than the rest of us.

Years later, when John hired our boys on hot summer days to help bring in hay, he would often let them drive his old tractor while <u>he</u> threw the 80 lb. bales from the ground to the top of the loaded wagon. Then, while they rested or ate lunch, he'd continue to load, or stack bales in the stifling heat of the loft. They sometimes laughed that John had paid them and then done more work than they had. But I was glad they'd had the opportunity to help John with the hay, sometimes rushing to get it in before the rain. John had once been the last in the area to farm with a "team" (of horses), and he was one of the last small dairy farmers around here. He was a diamond from an era which is gone.

John was the kind of man that if you asked me when we became friends, I wouldn't be able to tell you. Friends of John, and there were a lot of us, felt we had always been his friend. And now, from the perspective of many years, it does feel true.

I was so proud of our town after John & Kay's house burned. I think the stovepipe from the old wood heater in their kitchen started it. It was just poked through a hole in the wall, and not insulated well at all. It was a terrible fire. Then it seemed like everyone in town turned out to help them rebuild. One part of the old house wasn't burned too badly, so we cleared off the old kitchen and rebuilt the remaining wing into a new house for them. The town board even gave them a special exemption from the building code, which was probably illegal, but we all certainly agreed. The rebuilt house was smaller, but comfortable for the two of them, much better insulated, and safer, than the old place. They lived in it another 5 or 10 years - the rest of their lives.

The year before he died, when I'd gone over to visit one summer evening, John showed me his rhubarb, a long row of very large plants. Much more than he and Kay could use - it was clearly grown to share. After he had cut an extra-generous supply of stalks for me to take home, he asked if we had any plants. I also came away with two shovelfuls of roots to put in our garden. He never really asked if we wanted it - I think he was happy to give something away. It was a gift he had. They're special now, and seem so appropriate to remember him by.

A folksinger named Joni Mitchell once sang, "Don't it always seem to go, that you don't know what you've got till it's gone..." I did appreciate John, but never enough. I always wanted to get a picture of him on his tractor, yet I never took one. John Donne wrote, "Send not to know for whom the bell tolls; it tolls for thee." Don Welch June 14, 2006





## Hillside

## Amos Belden was born in New York

Cemetery City on August 6, 1853. As a young man he moved to Holley NV and opened a photographic moved to Holley, NY and opened a photographic business in the village. He entered into a partner-

ship with H.J. Buell and they ran a dry goods store along with a boots and shoe store. This store was located in the Buell block along with the State Exchange Bank. (This location is now an empty building; the Buell Block was razed before the current building was constructed). In 1880 Amos moved his photograph gallery to the Granite Block in Albion and opened another location on Main Street in Medina.









Amos Belden married Cora Morgan on May 4, 1882. Cora was the daughter of Alva S.

and Lucy Beebe Morgan of Holley. They had two children, a daughter who died at birth in 1884 and a son Amos Belden Jr. who was born on September 16, 1894. Sadly, Amos Jr. was killed in an automobile accident as he was traveling home on



Thanksgiving with his family just a year before his father died. Amos Belden Jr. was a graduate of Harvard University in 1916. Upon graduation he was employed with the National City Bank of New York. He served his first year of apprenticeship in London,

England. In 1917 he moved to the branch in Kobe, Japan. In 1928 he was promoted to the manager of the bank at Kobe, Japan. Amos, Sr. was prominent in musical circles and wrote several piano compositions. He was a proficient pianist. He held a meeting in Feb-



ruary 1891 to organize a choral society. He frequently held gatherings in his home for the purpose of singing and playing the piano. Amos Belden passed away on May 31, 1937 after being in poor health for some time. His wife Cora died on July 2, 1941 and was buried in the family plot with him.



multi-year permitting process before the NYS Board on Electric Generation Siting and the Environment Siting Board. Article 23 would implement a completely new siting process that takes land via eminent domain to develop shovel ready sites; these sites would then be ceded to developers to build wind/solar projects. This will help the state reach its'70 by 30' renewable energy and climate targets. Supervisor Moy stated there is much opposition across the state to Article 23. The Town Board adopted a Resolution declaring the Town of Clarendon a Local Control Town for Purposes of Article 23. General discussion was held regarding the Orleans County Radio Tower project. Supervisor reported that Dale Banker at Orleans County Emergency, county assessor and the county attorney are involved with review of the project. Radio Technologies is providing engineering services. This project is planned for placement on the Holley water tower parcel, which is in the Town of Clarendon. The Town of Clarendon was not informed or involved. Supervisor requested the county cease work and they did; a stop-work order was not issued, and procedure for this project in the town was started. It went before the Planning Board for review/permit; set-backs and one use per parcel can't be met with the project. On March 27, the Town Board held an emergency meeting via ZOOM Meeting Room on-line and discussed possible negotiations with the County regarding this project. Supervisor reviewed that the village owns 1/2 acre in the Town of Clarendon and no one seemed to know it was in our town. Jim Bensley at County Planning, the Code Enforcement Office or the County Planning Board had no involvement. The Board authorized the USDA access to all town properties for trapping and treating for the European Cherry Fruit Fly in the Town of Clarendon.

The Board has decided to proceed with preparing a Resolution establishing a meeting cancellation procedure (policy), delegating the supervisor authority to cancel a town board scheduled meeting. Action being taken because of the situation with the Coronavirus emer-The Board adopted a Resolution authorizing amendment gency. No. 1 of MRB Group Project Contract with regard to Clarendon Water District No. 13 to include a wetland presence/absence field investigation, preparation letter and report to be submitted to the U.S. Army Corp of Engineers.

As we navigate the new reality of life with a pandemic named Coronavirus, our schools are adapting as well and continuing to serve the community. Some people are working from home, some people are not working and then there are those deemed essential. When we think of essential workers we almost always think of hospitals, nurses and doctors. We think of grocery stores that have empty shelves as people panic and fear running out of supplies. Right here in Clarendon we see mostly empty streets and even fewer cars than normal traveling. Our local school district has since March 13th been planning and implementing things to help our students. Not only helping to keep some structure and maintaining a routine of learning but also making sure that students are able to eat. A very high percentage of students not only in Holley but around Orleans County are used to eating breakfast and lunch at school every day. Sometimes these are the only meals they would eat and now that school is closed, this could be an issue. Regardless of this, our district has and will provide meals to any child in the district under the age of 18 whether they attend Holley school or not. There are 4 locations around the district open from 8am-10am where bagged meals can be picked up. The folks working behind the scenes are Personal Touch Food Service, Buildings and Grounds, Transportation and volunteers. So far 6,988 meals have been served to our kids. That is almost 900 meals a day.
