**TAKE NOTICE** that at the November 17, 2020 meeting, the Clarendon Town Board adopted Local Law No. 6 of the Year 2020, A Local Law to Override the Tax Levy Limit Established in General Municipal Law 3-c. This local law authorizes the Town Board to override the limit on the amount of real property taxes that may be levied by the Town of Clarendon pursuant to General Municipal Law §3-c, and to allow the Town of Clarendon to adopt a budget for the fiscal year 2021 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

**TAKE NOTICE** that the Clarendon Town Board has introduced proposed Local Law No. 7 of the Year 2020, A Local Law Amending Local Law No. 3 of the Year 1988, Restricting Use of Town Highways by Commercial Vehicles with a Gross Vehicle Weight in Excess of Six Ton and has scheduled a Public Hearing to consider said law on December 15, 2020 at the Town Hall, 16385 Church Street, Clarendon, NY at 6:00 PM. Anyone wishing to be heard for or in opposition to the proposed local law will be heard at this time. It is the intent of this local law to add Brown Schoolhouse Road between NYS Route 237 and Upper Holley Road to the list of roads in Clarendon that are permanently closed to commercial vehicles with a gross vehicle weight in excess of six ton (12,000 pounds). A copy of the proposed law is available on the town website on the Legal Notice page, through email to [townclerk@townofclarendon.org](mailto:townclerk@townofclarendon.org) or at the Clerk's Office during regular business hours. **ALSO BE ADVISED** that the December monthly meeting of the Clarendon Town Board will commence upon close of said Public Hearing. *Pursuant to unknown COVID 19 changes in regulation of gathering, this meeting may necessitate use of ZOOM Group Meeting without time to publish the change. Please check the website or call the town hall to confirm whether the meetings will remain in person at the Town Hall or be a virtual meeting.*

## CLARENDON TOWN BOARD

### Meeting Highlights - October 2020

**HIGHWAY/WATER REPORT** - Superintendent Tracy Chalker reported that the plow trucks are all 100% ready for winter, the third roadside mowing is done and the painting of water hydrants is complete. The crew has been working hard at locating all water curb boxes and meter pits and marking for the new G.I.S. system. Our CHIPS money, Pave NY and Extreme Winter Recovery have all been submitted to NYSDOT and approved to be submitted to Albany for reimbursement. A new heater and emergency vent fan have been installed in the pump house at the water tower and a concrete slab in the sidewalk at the town hall has been replaced. There have been internet issues at the town barn; it seems to be fixed now. Thank you to Melissa for the assistance. A tap and push for a water service in Water Improvement Benefit Area 12 has been installed at a new house on New Guinea Road. Trees have been cleaned up that came down on Howard Road and one burial has been done at the cemetery. The highway dept. has signed a two year work-share program with the New York State DOT as part of a COVID 19 Emergency Plan. It had to be in place in case we need them or if they need us due to a COVID emergency. A copy of the 2020/2021 Clarendon Highway Department COVID 19 Emergency Snow and Ice Operation Plan was submitted to the Town Board. The crew has cleaned up multiple dead deer from the roadsides. Superintendent Chalker asked for the go-ahead with ordering the Mack 10 wheeler plow truck as originally spec'd out; that there would only be about \$500 savings to go with the Smith insert. For the minimal savings, Superintendent Chalker prefers to stay with what the town already has so the salt will be in the wheel track and high side of the road. Councilman Hovey not in favor of the purchase; that an insert can be used for multiple trucks purchased in the future saving money. Councilman Major in favor of the Mack as requested; that it is what the town already has. This item will be on the December agenda for further discussion. Work on the water G.I.S. system started Monday. One third of the town is marked out. It will be a long process. Superintendent Chalker submitted the Orleans County Hazard Mitigation plan update to the county.

**PLANNING BOARD REPORT** - Chairman Dave Griggs informed that a new cell tower is going up on Route 237 between the Kemp Farm and the Disciples Church. Chairman Griggs submitted the following written report: **November** (Action items only) **10-27-2020 Public Hearing** - Chairman David Griggs opened the public hearing at 7:00 PM with the Pledge of Allegiance and read the notice aloud. **LEGAL NOTICE - CLARENDON RESIDENTS TAKE NOTICE** - the Town of Clarendon Planning Board will conduct a Public Hearing, regarding a Special Permit Application prior to our regularly scheduled Planning Board Meeting on Tuesday, October 27, 2020 at 7:00 PM at the Town Hall, 16385 Church Street, Clarendon, NY. The applicant, Pyramid Network/Horvath-dba Verizon Wireless has applied for a Special Permit SP 20-19 Cell Tower/ Telecommunications Facility at 4514 Holley Byron Road tax id# 98.-1-11.1 All persons desiring to be heard in favor of or in opposition to this application will be heard at this time. For more information or questions regarding this application please contact Planning Board Secretary Melissa Ierlan at 638-6371 ext. 104. Chairman Griggs asked if there were any persons in favor or against this application three times. The applicant spoke in favor. There were no other responses and the public hearing was closed. **10-27-2020 Regular Meeting SD 20-19**, Pyramid Network Services/Horvath Communications/Verizon Holley Byron Rd. tax id# 98.-1-11.1 for site plan review to construct a communications tower. Various items were reviewed; height, curb cut, lighting, buffering, bond, address marker, copy of lease agreement, driveway specs, draft of Special Use permit conditions, etc.

No significant issues noted. The planning board will submit a packet up to the county Planning Board for review at their November meeting. Item carried on agenda as continuing business. **11-10-2020 Regular Meeting SD 20-21**, Scott Hanko/Sue Saucke, 17113 LaDue Road, tax id # 121.-1.53.1, pre-conference for a one (1) lot subdivision/Bldg lot approval. No issues noted with proposal, a motion was made, seconded and approved to declare this a minor subdivision for SEQRA purpose. a motion was made, seconded and approved to move from a pre-conference to a formal. A motion was made, seconded and approved to approve contingent upon creation of deed and filing with the county. **SP 94-005**, Diane Hillabush, 4229 S. Fancher Road, Beauty shop. Inspected, fee paid, no outstanding complaints. A motion was made, seconded and approved to renew.

**SD 20-19**, Pyramid Network Services/Horvath Communications/Verizon, Holley Byron Road, tax# 98.-1-11.1. A motion was made, seconded and approved to declare a negative declaration for SEQRA. The next regularly scheduled Planning Board meeting is 7:00 PM, November 24, 2020 at the Clarendon Town Hall, 16385 Church Street.

**SUPERVISOR REPORT** - Supervisor Dick Moy reported a telephone conference review with Standard & Poors (S & P); Accountant Tim Hungerford was also on the line. S & P reviews the town's budget and general obligations, determining our 'rating' for borrowing and interest rates. They don't like a fund balance in the budget being used to keep tax rates down as done in the past for water districts; they want to see money in a reserve fund therefore the 2021 budget will reflect that. No fund balances will be used to balance the budget; our Rating for borrowing and interest will remain an "A". Mitsubishi has been in contact regarding their solar project. They intend to apply late in 2021 or 2022.

**CORRESPONDENCE** - Supervisor Moy acknowledged the Clarendon Lions Club as a great organization that does a lot for the community. They have won a top 100 National Award for outstanding civic volunteerism; The Small Town America Civic Volunteer Award. The town has received payment from the Orleans Economic Development Agency of the Falls Railroad PILOT for 2020 in the amount of \$32.47. A copy of application filing for construction of a solar electric generating facility in the Town of Byron was received. MVP has sent notice of renewal and 2021 premium rates; increase is approximately \$5 per plan. The County has sent resolutions adopted by the Legislature, including the authorization capping the county's community college expenses.

**OLD BUSINESS** - The Town Board adopted a resolution authorizing a 25 MPH Speed limit on Pumping Station Road pursuant to a petition submitted requesting a lower speed limit; said authorization will be sent to the County Highway Department for approval and then on to the NYSDOT for approval. The Board adopted Local Law No. 6 of 2020 to override the tax cap and adopted a 2021 budget with an increase in rate of thirteen cents per thousand dollars of assessment; 2021 town tax rate will be \$5/per 1000.

**NEW BUSINESS** - The Board adopted a resolution introducing Local Law 7 of 2020 that will amend Local law 3 of 1988 Restricting Use of Town Highways by Commercial Vehicles with a Gross Vehicle Weight in Excess of Six Ton. (See front page for public hearing legal notice) The water maintenance agreement with the Village of Holley will be on the December agenda.







## CLARENDON LIONS CLUB

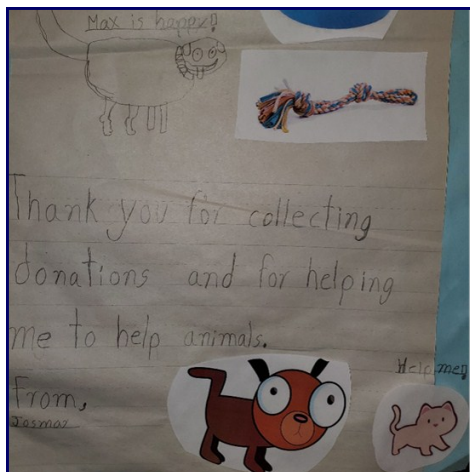

## Hillside Cemetery

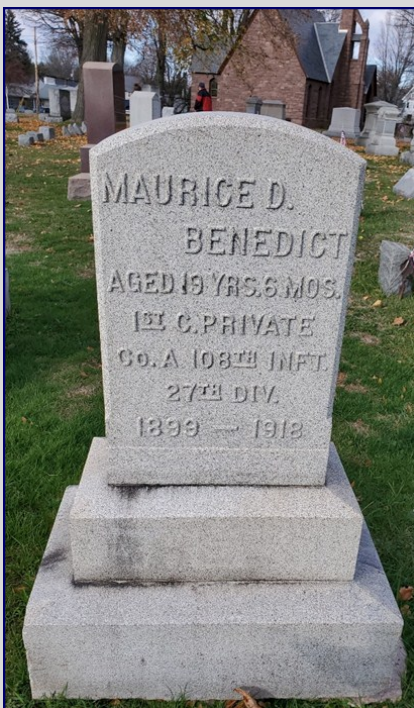
In November we celebrated Veterans Day so this young man's story is so relevant. Maurice D. Benedict was one the first to respond to his country's call, enlisting on his eighteenth birthday, only a few days after the United States entered the great conflict. *The United States declared war on Germany on April 6, 1917, nearly three years after World War I started.* Maurice was part of Co. A, Third N.Y. Regiment, later the famous 108<sup>th</sup> Infantry.

Maurice was wounded in action on September 30th while taking part in the drive which broke the Hindenburg line. After being transported to a hospital in England he wrote home. His letter home described what happened:

"I got hit in the stomach by a machine gun bullet. It went right through me, so was a clean



wound, and the doctors say I ought to be out in five weeks or so." "Well, I went over the top and forward till they got me. Our battalion got their objective and drove old Jerry better than 5,000 yards back toward Germany. Quite a number of our company were wounded. It sure was exciting and the boys went right through everything. When the bullet got me I went down. There were no stretcher bearers near, but I managed to get back to a dressing station. When they found it was a stomach case, they rushed me to a big hospital, where they found an operation was necessary."

Unfortunately, Maurice soon had pneumonia and other complications which ultimately led to his dying on October 22, 1918 at the 1<sup>st</sup> Southern General Hospital, Stourbridge England.

He was buried at Hillside in the family plot.





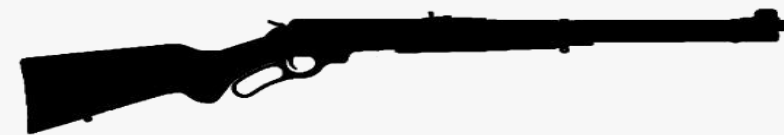
