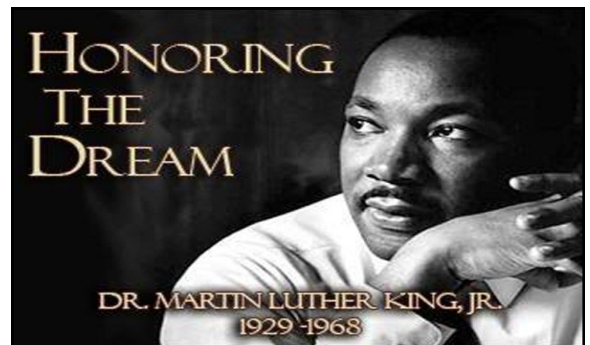

TAKE NOTICE that the Clarendon Town Board has adopted proposed Local Law No. 7 of the Year 2020, A Local Law Amending Local Law No. 3 of the Year 1988, Restricting Use of Town Highways by Commercial Vehicles with a Gross vehicle Weight in Excess of Six Ton. This local law did add Brown Schoolhouse Road between NYS Route 237 and Upper Holley Road to the list of roads in Clarendon that are permanently closed to commercial vehicles with a gross vehicle weight in excess of six ton (12,000 pounds) but will not be construed to prevent maintenance and local delivery or pick-up of merchandise or other property by commercial vehicles along the town highways. A copy of the proposed law is available on the town website on the Legal Notice page, through email to townclerk@townofclarendon.org or at the Clerk's Office during regular business hours.

CLARENDON TOWN BOARD

Meeting Highlights - November 2020

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the highway crew has been fixing potholes when weather permits. Work is being done on locating the curb boxes and valves for the GIS system. The department has been cleaning up a lot of dead deer on the roads and the plow trucks have been out three times so far. The Christmas decorations are up; two poles with electric plugs are not working. Superintendent has a call into the electric company. There have been issues with the Sterling; the wiring is rusted and has to be repaired. Superintendent Chalker has been working with the NYS DOT, the county and the other towns regarding a COVID emergency plan deciding who will care for the roads if a highway department has to shut down due to the virus. Two Welcome signs had to be reinstalled. Superintendent reported that on Thanksgiving Day he received a call that three stop signs were down; later two more signs. These were intentionally run over. The signs down and the damage on Bennetts Corners Road are costing the tax payers money. Stop signs cost \$136.34 each, plus labor and the risk of harm to residents. Superintendent suggested a notice be put in the Gazette for anyone with information to contact the authorities. Five trucks went in for inspection; no issues were found. Councilman Nicosia reported a resident concern he received; that the trucks were very heavily loaded with salt; that it makes the trucks over the weight limit on the road. Superintendent stated that the plow trucks are essential. Intent of the weight limit on town roads is to keep heavy trucks from continual use but they will still be used for maintenance and local deliveries. Resident was concerned when viewed the truck heaped with salt. Superintendent stated it is just heaped in the very middle; not in the whole box.

PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report: **11-24-2020 Regular meeting: SD 20-20**, Eric Lisher, pre-conference for a site plan review to construct a 24' x 32' pole barn for storage. Application is reviewed, a question regarding the required distance between overhead powerline and the proposed pole barn was raised. National Electric code will be reviewed for clarification by OIO. No other concerns were noted. The applicant requested to waive the pre-conference. A motion was made, seconded and approved to approve site plan contingent upon verification of the powerline question. **SD 20-21**, Hanko/Saucke one (1) lot subdivision. A motion was made, seconded and approved to declare this a minor subdivision for SEQRA purpose. **Planning Board Positions**, A motion was made, seconded and approved to recommend the following Planning Board appointments to the Town Board for their consideration and approval. David R. Griggs, Planning Board Chairman, one (1) year term to expire 12-31-2021. Kevin Johnson, Planning Board Deputy Chairman, one (1) year term to expire 12-31-2021. Kevin Johnson, Planning Board member, Five (5) year term to expire 12-31-2025. Kevin Johnson, County Planning Board, three (3) year term to expire 12-31-2023. Russ Bosch, Alternative County Planning Board, three (3) year term to expire 12-31-2023. Gary Thompson, Alternate Planning Board member, one (1) year term to expire 12-31-2021. **SD 20-19**, Horvath Communication/Verizon Cell Tower. A motion was made, seconded and approved to accept the County Planning Boards recommendations regarding this proposal.. **SD 20-19**, Horvath Communication/Verizon Cell Tower. A motion was made, seconded and approved to approve application as presented. **12-08-2020 Meeting** was cancelled due to insufficient agenda items.

HISTORIAN/HISTORICAL SOCIETY REPORT

Historian Melissa Ierlan thanked the Highway Superintendent for turning the water off at the Historical Society site. Also thanked was Cherie Brooks for decorating the stone store windows for Christmas and helping to sort and organize items inside the building. A.J. is wrapping up his Eagle Scout Project nicely. In reference to her 12/9/20 memo, Melissa reported that the Highway Department will get county equipment to knock down the two buildings on properties given to the town from the county; taxes were not paid prior to the annual property auction. Melissa asked for board approval to include knocking down the building on Tim Bopp's property on NYS Route 237; that Mr. Bopp has been working with the fire company for three years, completing work on the property requested so they could do a 'controlled burn' training exercise. The fire company has not followed through. If the town knocks it down, Mr. Bopp will bury the rubble. Councilman Major explained that when Jon DeYoung, Sr. was Chief, he agreed with the burn if certain conditions were met. Mr. Bopp did all the work requested and he said that he would pay for the water used in the burn. The current Chief has decided there will be no more controlled burns in the town because of the liability. The Chief has the final say and it's no. Councilmen and Supervisor in favor of excavation to eliminate risk; but that it is up to the county to give approval. The DEC has given its blessing if demolition permits are obtained from the town.

CORRESPONDENCE

The Town received Notice of a complete application filed for Article 10 from the Heritage Wind Project in the Town of Barre. Traffic Diversion Proceeds for the third quarter in 2020 were received in the amount of \$1,473.73. GLOW has sent notice of support for the town for outdoor tobacco free policies. This will be on the January agenda if the board wants to address it. The Orleans County Legislature has sent Mortgage Tax in the amount of \$24,092.36 for the period of April 1 through September 30, 2020. Association of Towns has sent information of 2021 all-virtual annual meeting and training school. New York Municipal Insurance Reciprocal has sent a check for return of capitalization in the amount of \$363.25. Orleans County has sent reimbursement of \$200.00 for DWI convictions in the Clarendon Court.

OLD BUSINESS

Supervisor Moy reported that the town is waiting for the state to review our request for speed limit reduction on Pumping Station Road; this can take from 6 to 8 months for an answer. The Town Board adopted a Resolution adopting Local Law No. 7 of 2020; A Local Law Amending Local Law No. 3 of the Year 1988 Restricting Use of Town Highways by Commercial Vehicles with a Gross Vehicle Weight in Excess of Six Ton. Supervisor explained that entities involved in the Joint Youth Recreation has taken turns handling the administrative duties of the programs for years. Mary Ridley has been handling the administrative/financial duties of the Joint Youth Recreation Programs on behalf of the Village of Holley; Mary will retire in December therefore the Village of Holley will not sign the agreement leaving it to continue said responsibility. Mary has volunteered to continue her services as an individual at no cost. Supervisor stressed the amount of work this takes; the Commission can decide to pay Mary a

Do we need such shadows here in our life?

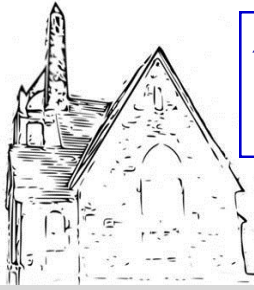

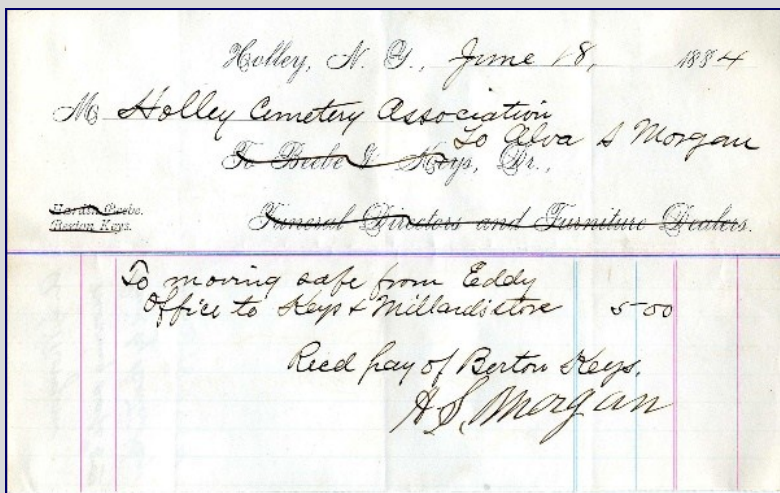

Hardin Beebe was born on March 28, 1826 and died on December 21, 1907. Hardin owned a farm in Murray. Hardin married Mary Pennell of Murray and they had two sons; Edson P. and Selden R. When Hardin built his house on North Main St. in Holley in 1890, his son Edson lived on and ran the farm. In 1880, Hardin Beebe, Frank Bishop and Fayette Milliken purchased a property on the corner of Geddes St. and the square which had been the scene of a big fire and built brick structures on that site.



Hardin served as a board member for the Holley Union School for some 20 years and in 1882 voiced his support for building a separate building fronting Main Street to accommodate the growing needs of the school. Other board members were polled and each had a different idea of what would best suit the students. One resident was quoted as saying that he would not send a child of his to the school in its present condition.

Hardin was in partnership with Berton Keys in the furniture and undertaking business. The firm was named Beebe & Keys for a time until Hardin retired and sold his interest to Alfred Millard and this partnership lasted until it was purchased in 1914 by John B. Merrill.

wage for handling it in the future. The Board did authorize revision of the Joint Youth Recreation agreement directing that Holley will no longer maintain the administrative responsibility for the Joint Youth Recreation Programs, but instead the Commission will appoint a person to handle the responsibility. The Town Board did authorize the purchase of a 2022 Mack Granite 64FR 10-Wheel Side Dump Plow Truck as proposed by Beam Mack Sales in E. Syracuse, NY at a total cost of \$249,112.91. The Village of Holley has agreed to renew its water maintenance agreement with the Town of Clarendon at the same rate for the Year 2021; the Clarendon Town Board authorized signing said agreement.

NEW BUSINESS

The following appointments were made: Reappoint Kevin Johnson to a five year term on the Clarendon Planning Board; term to expire 12/31/2025; Reappoint Ann Winkley to a five year term on the Clarendon Zoning Board of Appeals; term to expire 12/31/2025; Reappoint Nyla Gaylod to a five year term on the Clarendon Board of Assessment Review; term to expire 9/30/2025. The Board adopted a Resolution in support of an executive order to suspend the requirement to renew senior citizens exemptions for one year by local option. The Water District No. 13 Capital Project Budget was modified for specific account numbers to correspond with expenses. The Board adopted a resolution recommending reappointments to the Orleans County Planning Board for three year terms; Kevin Johnson as full representative; Russell Bosch as alternate representative. The Board scheduled the Organizational Meeting for the year 2021 to be held January 4, 2021 at 6:00 PM. *This is intended to be a ZOOM group meeting.*
