Meeting Highlights - January 2021

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the crew has been busy plowing roads, has worked with the Village of Holley through shared services and worked on truck maintenance; preventative and emergency. Salter chains were adjusted and repaired on two trucks and the spreader on the harder salter needed to be replaced. There was an issue with the Def. Line on #402 and it had to go to Beam Mack to be fixed. Building Maintenance: Pulled floor grates and cleaned the floor drain. All doors were cleaned and lubed and one overhead door needed repair. There have been a few issues with water meters freezing. Residents need to realize they have to keep them above freezing temps; basements heated or use heat tape. The equipment inventory has been reviewed. Superintendent Chalker is currently in Morrisville for a water conference to obtain his Grade D License and will be back on Thursday evening. Pete Surowy is in charge in his absence; the department is in good hands!

PLANNING BOARD REPORT

Chairman David Griggs submitted the following report:

Motion was made, seconded and approved to table this until survey maps are completed. **SD 21-02, Bill Fox**, Pre-conference for a site plan review to construct a 16' x 32' workshop and a 13' x 13' greenhouse, 5673 Upper Holley Rd. HISTORIAN/HISTORICAL SOCIETY REPORT

Historian Ierlan submitted the following written report: About 7 years ago I created a group on my Facebook page it is called: **Clarendon New York Historical Group**. It has 739 members as of today over 20 new members in the last month. I post the link to the Clarendon gazette every month and receive a lot of positive feedback for Susan.

I mainly used it to promote historical society events but as of the last year I post groupings of pictures from the area. I posted snow storm picture from 1944 and had a lot of people commenting about what they remember. It is so nice to be able to share these things. People often thank me for posting old pictures.

I have had several people visit the stone store to look at the progress that we have made displaying our collection. As a result, I have had people share old family photos and now they are in my collection.

I was invited to attend Troop 59 Klondike Day at the Disciples United Methodist Church yesterday. It was very cold but there were a dozen kids and some parents and troop leaders there. The kids used sleds that were made years ago by former scouts. They did a challenge to see which person with a passenger on board could pull the sled around a course the fastest. The winner was Kalen Brady with 35 seconds. Lunch was served along with hot cocoa. It was a nice event.

Kathleen Clarke ordered a bench in memory of her husband Robert Clarke Jr. who passed away in 2018. Bob was a very involved community member and was on our Zoning Board of Appeals when he passed away. This bench will be installed at the Clarendon Historical Society as it was one of the places Bob and Kathy liked to go for monthly programs and the town annual cookout. I was able to convert cassette taped interviews from 2005 into digital files of the following people: Albert Blank, Bill Hilfiker, Bill Root, Bob Woodworth, Charlie Robishaw, Dick Moy, Dudley Mathes, Ethelyn Clark, Everett Campbell, Gerald and Arlene Robinson, Harold Hefke, Jessie Moore, Jim Moore, John and Eva Kinsey, Joyce Blank, Kathleen Smith, Lewis Bowen, Mary Webster, and Rich Williams. If anyone would like a copy they can be burned on to a DVD or copied to a thumb drive.

CORRESPONDENCE

The Town has received updates on the Heritage Wind project in the Town of Barre. Association of Towns has sent 2021 conference information. The New York State Comptroller has sent notice of distribution of local sales tax revenue in Orleans County. The Orleans County District Attorney has sent Traffic Diversion Program proceeds and the town has received an abstract of 2020 Revenues from Orleans County.

OLD BUSINESS

The State has not approved the request for a speed limit on the Pumping Station Road. Superintendent Chalker explained that when the gun club has a lot of activity, cars north bound off South Holley Road onto Pumping Station, go quite fast. Discussion was held regarding a sign to slow traffic down from that end of the road. The Assessor gave Supervisor Moy a note stating that \$12,000 was a reasonable list price for the 16572 Boots Road property; Councilmen felt that an interested party could counter offer a purchase price. It was estimated that cost to demolish the house on the parcel would be \$10,000. OIO Ierlan confirmed the septic system un-usable, the foundation is rubble and there is no public water available there if someone was to rebuild there.

NEW BUSINESS

The Board accepted the bid to care for the town hall garden for the 2021 season from Beth Skehan, Church Street resident, for a flat rate of \$525.00 and accepted a Notice of Resignation from Town Hall Cleaning Service from Cindi Davis, effective February 14, 2021. Discussion was held regarding the Joint Youth Recreation. An agreement was adopted for two years at an annual contribution of \$1850.00 for the period of the agreement. Old Business Item 2 was reviewed with Supervisor Moy. Assessor viewed the property and agreed that a starting point should be \$12,000; with the condition that the structure be torn down.

Hillside Cemetery

It is not often that you find a family who has lived in the same location for over 160 years. Here in Clarendon, I found just that. Generation after generation

of the Bartlett family have owned, farmed and lived on 108 acres just off South Holley Road. Over 40 Bartlett descendants are buried in Hillside Cemetery not counting the many relatives with different surnames.

It all started with Samuel G. Bartlett who was born on March 17, 1798 in New Hampshire. He married in 1826 and his family moved to Sweden, Monroe County and are listed in the 1830 federal census. Samuel then relocated to Clarendon around 1854 and purchased 108 acres of land. Samuel and his wife Elmira had 6 children. Their son John Reed Bartlett also moved to Clarendon and eventually after Samuel passed away, took up residence on the South Holley Road. John married Sarah M. Darrow in 1857, they had two children Clarisa and Lewis Darrow Bartlett. Lewis married Cora Rodwell in 1886 and they had one child. Chester Lewis Bartlett born March 3, 1895 was raised on South Holley Road.



He attended the Holley Academy which was torn down in 1830 to make way for the "New" Holley High School which stands today and has been restored and converted into apartments and the village of Holley Offices. Chester married Mildred Reitz in May 1922. They had one son; Lee C born on Dec. 12, 1935.



Chester was an avid hunter and outdoorsman. He worked on the family farm and enjoyed all that country life had to offer.

His family was among the first locals to own an automobile and Chester had an Indian motorcycle around the time he graduated high school.



As the town historian, I have been very fortunate to have access to family photos and journals that depict an era in history that was vastly different than today. They worked hard, played hard and were very family oriented. Life revolved around work, religious beliefs and community. The Bartlett family has given us a rare glimpse into what life was like in Clarendon in the early 1900's and the family friends and neighbors who were part of it.

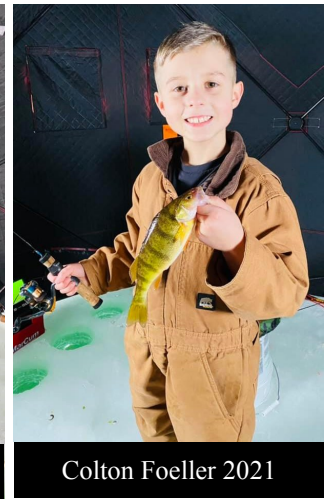

Check the back of your detector for either a build date or an expiration date. If there's no date or your CO monitor is more than seven years old, replace it now. If you wonder if your carbon monoxide detectors are worn out, they probably are. CO detectors only have a five to seven-year life.

Discussion was held regarding the help of a professional; Supervisor will contact Howard Hannah (a local realtor in Brockport); this item to be on the March agenda. Supervisor Moy reported Assemblyman Steve Hawley spoke about the state budget today on the weekly County ZOOM meeting; that the Governor has included legalizing Marijuana. Research has shown that states that have passed this already have seen nowhere near the revenue anticipated, but fatalities have tripled. The Governor is looking at the revenue side. Councilman Robinson acknowledged Cindi Davis for being a great employee; as the Assessor and then the cleaning service. Supervisor Moy agreed that she has been a big asset to the community. Supervisor informed receiving a phone call from a gentleman about the advertisement for the cleaning bid; that he told him to come to the town hall and he could see what the job entailed. Supervisor reported that employees will clean their own offices now for security purposes and the town will contract only to have public rooms cleaned.
